- (i) The candidates who appeared in the Entrance Test of B.V.Sc.&A.H. programme held on 14.07.2019 have to login with their application ID and Password at university website www.luvas.edu.in for filling up of preferences of colleges for State Quota Seats (for COVS, LUVAS & IIVER, Bahu Akbarpur, Rohtak) and Management Quota Seats (for IIVER, Bahu Akbarpur, Rohtak).
- (ii) The candidates have to submit/lock their choices separately for State Quota seats (for COVS, LUVAS, Hisar and IIVER, Bahu Akbarpur, Rohtak) and Management Quota seats for IIVER, Bahu Akbarpur, Rohtak before due dates as mentioned above.
- (iii) Only the candidates who will submit/lock their choice(s) shall be eligible for allotment of seats.
