Counselling/Registration schedule for admission to B.V.Sc.&A.H. programme for  
International Institute of Veterinary Education & Research (IIVER), Bahu  
Akbarpur, Rohtak for the session 2017-18

## IMPORTANT

*“The candidates are advised to go through the below given instructions carefully before reporting for counselling”.*

### I. STATE QUOTA SEATS (1<sup>st</sup> Counselling) :

- A. Reporting Date & Time – 27.09.2017 at 9.30 A.M.
- B. Venue:
  - (i) Attendance – Veterinary Auditorium, LUVAS, Hisar
  - (ii) Counselling - (Verification & Submission of original & two sets of photocopies of certificates/documents) - Committee Room of Dean, College of Veterinary Sciences (COVS).
- C. Candidates to report for counselling - Only Haryana resident candidates who appeared in the entrance test of B.V.Sc.&A.H. programme 2017-18 conducted by LUVAS are eligible for counselling for State Quota Seats.

### II. MANAGEMENT QUOTA SEATS (1<sup>st</sup> Counselling) :

- A. Reporting Date & Time – 28.09.2017 at 10.00 A.M.
- B. Venue for Counselling - (Verification & Submission of original & two sets of photocopies of certificates/documents) at Campus of IIVER, Bahu Akbarpur, Rohtak
- C. Candidates to report for counselling - All the candidates (Haryana residents as well as belonging to other states of India) who appeared in the entrance test of B.V.Sc.&A.H. programme 2017-18 conducted by LUVAS are eligible for counselling.

### III. 2<sup>nd</sup> Counselling for vacant seats (State and Management Quota seats) :

- A. Reporting Date & Time – 29.09.2017 at 9.30 A.M.
- B. Venue:
  - (i) Attendance – Veterinary Auditorium, LUVAS, Hisar
  - (ii) Counselling - (Verification & Submission of original & two sets of photocopies of certificates/documents) - Committee Room of Dean, College of Veterinary Sciences (COVS).
- C. Candidates to report for counselling - Haryana resident candidates for State Quota seats and all the candidates (Haryana residents as well as belonging to other states of India) for Management Quota seats; who appeared in the entrance test of B.V.Sc.&A.H. programme 2017-18 conducted by LUVAS.

*Note:* 1. Fee & other Dues for State quota seats (1<sup>st</sup> counselling): An amount of Rs.3,57,500/- (i.e. Rs.2,27,500/- as fee and Rs.1,30,000/- as security) will have to be deposited at LUVAS (through Bank Demand Draft in favour of Dean, College of Veterinary Sciences, LUVAS, Hisar payable at any scheduled bank at Hisar or by any other mode) by the candidates to be admitted against State quota seats at the time of counselling itself otherwise they will not be considered for admission. Rest of the amount of other dues is to be deposited with IIVER, Bahu Akbarpur, Rohtak by 11.30 am on 28.09.2017.

2. **Registration of the candidates admitted during 1<sup>st</sup> counselling against State Quota Seats will be at the IIVER, Bahu Akbarpur, Rohtak after 11.30 a.m. on 28.09.2017 i.e. after deposition of complete fee & dues.**
3. **Fee & other Dues for Management quota seats (1<sup>st</sup> counselling):** The total amount will have to be deposited with IIVER, Bahu Akbarpur, Rohtak at the time of counselling itself otherwise they will not be considered for admission.
4. **Registration of the candidates admitted during 1<sup>st</sup> counselling against Management Quota Seats will be at the IIVER, Bahu Akbarpur, Rohtak on 28.09.2017 itself after deposition of complete fee & dues.**
5. **Vacant Seats :** The number of seats remaining vacant after 1<sup>st</sup> counselling of State as well as Management quota seats will be uploaded on the University website on 28.09.2017 evening.
6. **Fee & other dues and Registration after 2<sup>nd</sup> Counselling :**  
*The candidates to be admitted during 2<sup>nd</sup> Counselling against the vacant seats of State and Management quota will be required to deposit total amount at the time of counselling i.e. 29.09.2017 otherwise they will not be considered for admission and the Registration will be on 29.09.2017 itself after deposition of complete fee and dues.*
5. *The candidates are advised to visit the university website before reporting for counselling/registration.*
6. *All the candidates are advised to bring original as well as two sets of photocopies of all the documents/certificates, as mentioned in the prospectus and two passport size coloured photographs at the time of counselling.*
7. *The candidates belonging to BCA/BCB categories seeking admission under State quota seats have to submit latest income certificate at the time of counselling otherwise their candidature for admission will not be considered.*
8. *The children of persons of Backward Classes having gross annual income of up to three lakh rupees shall first of all get the benefit of reservation in admissions. The left out quota shall go to that class of Backward Classes of citizens who earn more than three lakh rupees but up to six lakh rupees per annum. The sections of the Backward Classes earning above six lakh rupees per annum shall be considered as creamy layer.”*

**Note :** **Registration prior to counselling :** *The candidates appearing for counselling for admission against State as well as Management quota seats are required to register themselves with IIVER prior to the counselling by paying an amount of Rs.500/- each.*
